

TRASH & RECYCLING PICK-UP

Provided by Johnson County Refuse 319-665-4498.
Curbside pickup 7:00am Thursday mornings.
Any holiday changes will be announced.

Garbage Containers:

65-gallon container: \$13.50/month
35-gallon container: \$11.50/month

Commercial & Residential Buildings greater than 6 units must contract for service.

Any garbage that does not fit in the container needs to be in a bag no larger than 35-gallon with a 40lb weight limit, placed on top of can with lid closed and with 1 sticker on bag. Stickers are sold for \$3.00 at The Depot Convenience Store & Fareway.

Commercial Entities and Residential Buildings of greater than 6 units must contract for service.

Recycling Containers:

65-gallon container: \$5.50/month
95-gallon container: \$5.50/month

No separation is required. All recycling must be clean. NO PLASTIC BAGS.

WE DO NOT RECYCLE: Styrofoam, window glass, mirrors, electronic waste, motor oil containers, yard waste, chemical containers, plastic bags, ceramics or dishes, food waste, scrap metal, monitors, medical needles or waste, animal food bags or kitty litter bags.

Yard Waste:

Not allowed in garbage pickup.

City provided collection site for residents is located off Mehmen Ave., South of the railroad by the Water and Sewer Plants for yard waste, limbs, and branches smaller than 2" in diameter.

Large items or prohibited items

Take to Iowa City Landfill 319-356-5185.

Contact City Hall to obtain new or report stolen container.

BUILDING PERMITS

Permits are required for most types of remodeling and repairs. All new construction requires a permit. Zoning Code & Design Standards adopted 2007 as well as the current International Building Codes and updated annually. PET REGULATIONS

Animals must be registered with the city per City Ordinance every calendar year.
\$10.00 annual registration fee.
\$4.00 reduced annual registration fee in December for the upcoming year.

When applying, you must provide current vaccination records from a licensed Veterinarian. Animals will need to be licensed as soon as they reach seven months.

City ordinance allows three dogs and three cats in residential zones. Puppies will be considered dogs at eight weeks and at that time they will fall under the three dogs' limitations.

Pets must be under control and restrained by competent person. Pets must be on leash at all times when off owner's premises. Any animal found off premises of its owner at large will be collected for impoundment. Impounding fees and boarding costs will be charged for any animal picked up at-large and released to an owner.

Disturbances caused by a pet such as howling, yelping, or barking are all prohibited and may bring cause for summons if these types of problems are brought to the attention of City officials. It is unlawful to keep a vicious animal. It is unlawful for the owner of an animal to allow or let such animal to pass onto the premises of another thereby causing damage or interference. Livestock is not allowed in non-agricultural residential areas. Violators may be assessed City infractions by Ordinance.

DOG PARK

Tiffin's Dog Park is located off Kimberlite St in City Park. To utilize the dog park you must purchase a yearly Dog Park Pass for \$5.00.

WATER AND SEWER SERVICE

Residents are required to contact the Utility Department at Tiffin City Hall to set-up or discontinue their Utility Account prior to move-in or move out date at: (319) 545-2572 Monday - Friday, 8:00-4:30 pm.
New-build units will require the connection of a water meter.

Water and Sewer service is billed monthly.
Meters are read on the 15th of each month (unless it is a weekend, then the next business day)
Bills are sent out on the 1st of each month
Payments are due on the **20th** of each month.

- ACH Auto Withdrawal: Fill out form & provide voided check to City Hall for auto payments on the 20th of every month

Water service is billed:

Base Rate - \$7.00 per month

Flow Rate - \$5.50 – equal to \$0.0055 per gallon

Sewer service is billed:

Base Rate - \$19.50 per month

Flow Rate - \$4.75 – equal to \$0.00475 per gallon

Sales tax is billed at:

6% for water service for residential units.

Commercial units are billed sales tax at 6% for both water and sewer service.

Storm Water Utility Fee:

\$5.00 for Business and \$3.00 for Residential

City Ordinance requires:

\$120 Water Deposits on all rental units, to be on first utility bill. Water deposits are refundable upon move out and account paid in full.

Failure to pay monthly bill will result in a late fee. Notice and disconnection procedures to follow delinquent payment. Re-connection fees are \$25.00 per City Ordinance.

Water and Sewer testing is conducted as required by the Federal and State strict standards. Public Works personnel are certified in Water and Sewer testing and treatment as required. Public Works officials are required to gather spigot water samples from various locations within the Utility Service area. Emergency telephone 319-631-1698.

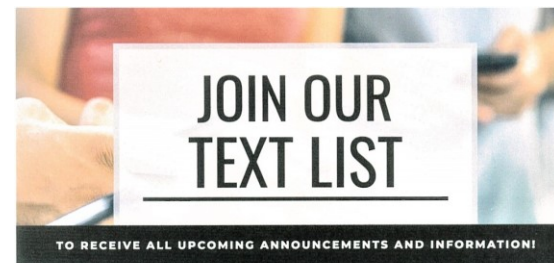
NEIGHBORHOOD RULES

Noise: Construction not before 7:00am or after 10:00pm.

Snow Removal: Residents have 48 hours to remove snow and ice from sidewalks. Please clear around mailboxes and fire hydrants.

Snow Emergencies: 4 hours to move vehicles off all streets. Plowing order: arterial streets, secondary streets, and country roads last. Report vehicles not moved in timely manner.

Lawn Care: Nuisance Ordinance in place. Growth cannot exceed 8 inches tall.
